In the case of a resident who has been adjudicated mentally , the guardian shall be given at least 45 days' notice of a nonemergency relocation or residency termination. Reasons for relocation shall be set forth in writing. In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without , interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. (2) The administrator of a facility shall ensure that a written notice of the rights, , and prohibitions set forth in this part is posted in a prominent place in each facility and read or explained to residents who cannot read. The notice must include the statewide toll-free telephone number and e-mail address of the State Long-Term Care Ombudsman Program and the telephone number of the local ombudsman council, the Elder Hotline operated by the Department of Children and Families, and, if applicable, , Rights Florida, where complaints may be lodged. All door had doorknobs but did not have a locking mechanism. In an interview on _____ at 12:45 PM the administrator said she turned the lock inside in one room only; for resident #3 and #4. Resident #3 thought resident #4 was his wife and had a boyfriend at the facility. He barricaded themselves in the room, he sat in the wheelchair and parked it in front of the door. The male staff was unable to open the door until resident #3 moved out of the way. The facility did not have a key to that room. After speaking with the adult protective investigator, she changed all the locks to how they are now. If a resident wanted a key, she would install a locking knob. She added that the non - locking doors did not violate the resident's rights as the door closed and the staff would never enter without knocking first . Class III	A 030
