(6) Any resident accepted in a facility and placed by the department or the Department of Children and Families shall have been examined by medical personnel within 30 days before placement in the facility. The examination shall include an assessment of the appropriateness of placement in a facility. The findings of this examination shall be recorded on the examination form provided by the agency. The completed form shall accompany the resident and shall be submitted to the facility owner or administrator. Additionally, in the case of a mental health resident, the Department of Children and Families must provide documentation that the individual has been assessed by a psychiatrist, clinical psychologist, clinical social worker, or nurse, or an individual who is supervised by one of these professionals, and determined to be appropriate to reside in an assisted living facility. The documentation must be in the facility within 30 days after the mental health resident has been admitted to the facility. An evaluation completed upon discharge from a state mental hospital meets the requirements of this subsection related to appropriateness for placement as a mental health resident providing it was completed within 90 days prior to admission to the facility. The applicable department shall provide to the facility administrator any information about the resident that would help the administrator meet his or her responsibilities under subsection (1). Information received orally must include the name of the health care provider, the name of the facility staff recording the information, and the date the information was provided. 3. Electronic documentation may be used in place of completing the section on AHCA Form 1823 referencing Services Offered or Arranged by the Facility for the Resident. The electronic documentation must include all of the elements described in this section of AHCA Form 1823. On page 4, Section B of AHCA form 1823, a checkmark was shown in the box indicating the individual "Needed Medication Administration." Photographic evidence was obtained. A record review was conducted for Resident #4 on _____. The AHCA form 1823 dated _____ for Resident #4 was reviewed and revealed it was not complete and accurate. On page 4, Section B of AHCA form 1823, "does the individual need help with taking his or her medications (meds)" had no checkmark for yes or no and there was a checkmark in the box indicating the individual "Needed Medication Administration." Photographic evidence was obtained. During an interview on _____ at 2:45 PM with the Administrator and Resident Care Director, they confirmed that Resident #1 and Resident #4's AHCA form 1823 were not complete and accurate. They acknowledged that both residents did not need Medication Administration, which requires nurses to administer and stated the form should have been filled out showing they Needed Assistance with Self-Administration. In addition, they confirmed that Resident #4's AHCA form 1823 did not indicate if resident needed help with taking her medications as required.	A 008
