Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from _____ and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without _____, interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. (2) The administrator of a facility shall ensure that a written notice of the rights, _____, and prohibitions set forth in this part is posted in a prominent place in each facility and read or explained to residents who cannot read. The notice must include the statewide toll-free telephone number and e-mail address of the State Long-Term Care Ombudsman Program and the telephone number of the local ombudsman council, the Elder _____ Hotline operated by the Department of Children and Families, and, if applicable, _____, Rights Florida, where complaints may be lodged. The notice must state that a complaint made to the Office of State Long-Term Care Ombudsman or a local long-term care ombudsman council, the names and identities of the residents involved in the complaint, and the identity of complainants are kept confidential pursuant to s. 400.0077 and that retaliatory action cannot be taken against a resident for presenting grievances or for exercising any other resident right. (b) The admission of a resident to a facility and his or her presence therein shall not confer on the facility or its owner, administrator, employees, or representatives any authority to manage, use, or dispose of any property of the resident; nor shall such admission or presence confer on any of such persons any authority or responsibility for the personal affairs of the resident, except that which may be necessary for the safe management of the facility or for the safety of the resident. This Statute or Rule is not met as evidenced by: Based on interview, observation and record review , the facility failed to safe guard the residents' well being by failing to follow current control standards related to the COVID-19 recommendations set forth by Centers for Control and Prevention (CDC) and Department of Health (DOH). As evidence of the facility failure to attain necessary Personal Protective Equipment, and failed to develop Policies and Procedures to prevent the introduction and spread of COVID 19. A 030	Continued From page 6 During an interview with the Administrator/Owner, on beginning at 1:00 PM, the Administrator was asked about the facility's supply of Personal Protection Equipment (PPE), she replied that she had one (N95) mask and did not have any masks for the residents. She had one opened box of single use gloves, and 3 bottles of 4 ounces sanitizer. When asked what has been done to attain more PPE, the Administrator stated, she had been trying on her own to get PPE from the grocery stores with no success. She further stated, the Palm Beach County Department of Health (DOH) called at the end of the previous week (was unsure of actual day or date) to make sure we had supplies. We told them 'no supplies' and they said that they would order them for us. When DOH came, I did not sign any requisitions and I don't know for sure if it was the Department of Health. She further stated, the Health Department said they were going to bring some, but they haven't brought anything yet. The Administrator/Owner informed this surveyor that she had not filled out any requisitions to attain PPE from the local health department and had not reached out to emergency responders or Emergency Operations Center (EOC) for assistance. When asked about reaching out to local emergency responders or any other resources, she replied that she did not know there were any other resources that she could use or reach out to. The Administrator agreed to fill out a requisition with the Department of Health and called a 'friend' to send her a link to fill out the requisition. She then showed this surveyor her smart phone with a link for requisition but had not begun the process. When the Administrator/Owner was asked about	A 030

A 030	Continued From page 7 monitoring the residents for signs or symptoms of COVID 19, she stated, "I check them twice a day, in the morning and in the afternoon, with temperatures" When this surveyor requested logs documenting the monitoring, the Administrator/Owner stated that she did not document the temperatures. The Administrator was asked about the facility's policies and procedures for using and monitoring PPE, she replied that there was none. When this surveyor requested the facility's Control policies and procedures, the Administrator provided the Visitor Screening toolkit, sample communication letters and templates for 3rd party vendors and visitors and a transcript from a press conference by the Governor of Florida. A review of the information given in reference to monitoring and use of PPE, monitoring residents for signs and symptoms, and no actual Control Policy and Procedure. Class II	A 030
