Review of the facility "COVID-19" Control Recommendations for COVID-19" policy and procedures dated on 4/23/2020, indicated that the facility will implement control and prevention strategies on resident with COVID-19 symptoms. Further review of this document did not indicate any specific COVID-19 hygiene strategies or resident isolation techniques for residents without symptoms to prevent the spread of potential Review of the "Considerations when preparing for COVID-19 in Assisted Living Facilities" guidelines published by the CDC on 4/23/2020, it indicated that facility staff must encourage the residents to remain inside their bedrooms as much as possible and must have residents wear a face covering whenever they were not inside their bedrooms, regardless of whether a resident had any symptoms. In an interview with the administrator on 4/23/2020 at 10:50am, she stated that she was aware of the most current CDC recommendations to prevent and reduce the spread of Coronavirus in assisted living facilities.
