Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. (2) The administrator of a facility shall ensure that a written notice of the rights, , and prohibitions set forth in this part is posted in a prominent place in each facility and read or explained to residents who cannot read. The notice must include the statewide toll-free telephone number and e-mail address of the State Long-Term Care Ombudsman Program and the telephone number of the local ombudsman council, the Elder Hotline operated by the Department of Children and Families, and, if applicable, Rights Florida, where complaints may be lodged. The notice must state that a complaint made to the Office of State Long-Term Care Ombudsman or a local long-term care ombudsman council, the names and identities of the residents involved in the complaint, and the identity of complainants are kept confidential pursuant to s. 400.0077 and that retaliatory action cannot be taken against a resident for presenting grievances or for exercising any other resident right. Have you traveled internationally? Have you been around anyone with the _____?" She then asked a health care provider who had entered _____, with the surveyor "How about you?" The concierge then documented "N" on a Covid-19 screening tool, drew a line through the answer boxes of all the questions and allowed entry into the facility. (photographic evidence obtained.) Review of the screening tool revealed that in addition to a specific list of signs and symptoms to be asked, the following questions were also included: had direct contact with someone while on duty who is Covid-19 positive and did not use PPE; had prolonged direct contact with someone who has taken a Covid-19 test but does not have the results _____ yet; and had direct contact with someone who is Covid-19 _____ and did not use PPE worked in another healthcare setting that has confirmed Covid-19 and did not use PPE. None of these questions were specifically asked of either the surveyor or the health care provider who entered the facility. When the concierge was asked why she did not ask all the questions on the screening tool, she replied "I thought because you were AHCA (Agency for Health Care Administration)."
