(b) New staff must complete the preservice orientation prior to interacting with residents. (c) Once complete, the employee and the facility administrator must sign a statement that the employee completed the preservice orientation which must be kept in the employee's personnel record. (d) In addition to topics that may be chosen by the facility administrator, the preservice orientation must cover: 1. Resident's rights; and, 2. The facility's license type and services offered by the facility. (3) STAFF IN-SERVICE TRAINING. Facility administrators or managers shall provide or arrange for the following in-service training to facility staff: (a) Staff who provide direct care to residents, other than nurses, certified nursing assistants, or home health aides trained in accordance with rule 59A-8.0095, F.A.C., must receive a minimum of 1 hour in-service training in control, including universal precautions and facility sanitation procedures, before providing personal care to residents. All facility staff shall demonstrate an understanding and competency in the implementation of the elopement response policies and procedures. This Statute or Rule is not met as evidenced by: Based on record review and interview the facility failed to ensure 1 of 4 staff (A) received all the required training. Findings: Personnel record review for staff A revealed she was hired and was a caregiver. The review revealed several certificates dated that indicated a 1- hour training regarding elopement and 1- hour /Neglect/Resident's Rights, a 1- hour emergency procedure, and adverse reporting. All the certificates were from an on-line training Internet site and the training was not specific to the facility's policies and procedures regarding the reporting of elopement and emergency procedures, evacuation, including chain of command. In an interview with a corporate officer who said when the management company changed, staff were required to take all in-services again and evidently staff A was missed. Class III	A 081
