(1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. (2) The administrator of a facility shall ensure that a written notice of the rights, , and prohibitions set forth in this part is posted in a prominent place in each facility and read or explained to residents who cannot read. The notice must include the statewide toll-free telephone number and e-mail address of the State Long-Term Care Ombudsman Program and the telephone number of the local ombudsman council, the Elder Hotline operated by the Department of Children and Families, and, if applicable, Rights Florida, where complaints may be lodged. The notice must state that a complaint made to the Office of State Long-Term Care Ombudsman or a local long-term care ombudsman council, the names and identities of the residents involved in the complaint, and the identity of complainants are kept confidential pursuant to s. 400.0077 and that retaliatory action cannot be taken against a resident for presenting grievances or for exercising any other resident right. On June 1, 2020, the Governor of the State of Florida issued Executive Order 20-51 designating a Public Health Emergency as a result of COVID-19 and its impact. Pursuant to that authority, emergency orders have been issued by the Florida Division of Emergency Management to implement the protections necessary to assure the health, safety, and well-being of Florida's citizenry, including those most vulnerable to the effects of COVID-19. Among those emergency orders was DEM Order 20-006, dated June 1, 2020, delineating a discontinuation of visiting for residential facilities. A review of the Florida Governor's Emergency Order No. 20-006 showed that individuals were prohibited from visiting Assisted Living Facilities except for relatives or friends in end-of-life situations; hospice or health care providers; facility staff and residents; and government representatives who were not positive or negative for COVID-19. On June 1, 2020 at 8:30 AM, observation revealed Non-Resident #6 sitting in a chair at the entrance of the facility. On June 1, 2020 at 8:35 AM Staff B stated that Non-Resident #6 was actually a daycare participant that came to the facility every day at 7:00 AM and went home in the afternoon. On June 1, 2020 at 8:50 AM during a phone interview, the Owner stated that Non-Resident #6 had been coming to the facility as a daycare participant since January 2020, and that his wife was bringing him	A 030
