The facility did not have an entrance log and health questionnaires available. In the living room were observed Residents #1, #2, #3 and #4. They were not maintaining the 6 distance between them, and they were not wearing masks. Staff A, when asked why she did not conduct the COVID-19 screening, and why facility did not have a signing log and health questionnaire, she stated: "nobody comes here". On at 11.30 AM Staff C arrived wearing a surgical mask. He entered the facility without conducting any COVID-19 screening. When asked why she did not have an entrance log and screening questions, she stated, 'Nobody enters the facility.' On at 11.30 Staff C stated Staff A did not conduct the screening because she got nervous about the AHCA visit. She stated the consultant was preparing the logs and health questionnaires.
