In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (I) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without interference, coercion, discrimination, or reprisal. Planned menus must be conspicuously posted or easily available to residents. Regular and therapeutic menus as served, with substitutions noted before or when the meal is served, must be kept on file in the facility for 6 months. (e) Therapeutic diets must be prepared and served as ordered by the health care provider. 1. Facilities that offer residents a variety of food choices through a select menu, buffet style dining, or family style dining are not required to document what is eaten unless a health care provider's order indicates that such monitoring is necessary. Observations on _____ at 12:30 PM revealed there were 5 menus posted on the board by the dining room and they were not dated. The facility used a menu cycle log that included the date that each cycled menu was to be used for the current week _____ it noted week 3 menu was to be used. Review of the menu that was in use revealed it was week five. The log posted the included menu dates was not accurate.
