Reasons for relocation must be set forth in writing and provided to the resident or the resident's legal representative. The notice must state that the resident may contact the State Long-Term Care Ombudsman Program for assistance with relocation and must include the statewide toll-free telephone number of the program. In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without _____, interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. The findings include: An interview was conducted with the Executive Director (ED) and Director of Nursing (DON) on at 12:55 PM. They both confirmed that Resident #1 was restrained by a staff member on , who tied him to his wheelchair with a white bed sheet around his waist. The ED and DON confirmed they called the law enforcement office (LEO) and the Department of Children and Family (DCF) on to investigate the incident. The ED and DON stated that they were not aware the Agency for Health Care Administration (AHCA) required an adverse incident report to be submitted as LEO and DCF were called.
