The findings included: Observation upon arrival to the facility on at 8:10 a.m., found Staff A opened the door without wearing a mask. Staff A said at time of observation she did not wear a mask because she was drinking some milk. The kitchen counter was behind Staff A. No milk or empty glass was observed. Staff A walked to the opposite side of the facility and obtained her mask. The surveyor waited for the staff to return and provide screening. No screening took place. On at 8:31 a.m., the administrator arrived in the facility. No screening was observed taking place when he arrived in the facility. It was explained to the administrator the issue related to lack of screening. He began looking for the form on at 8:33 a.m. The administrator could not locate the screening form. Staff A and B tried looking for the screening form on at 8:35 a.m. Staff A and B could not find the screening form either. The administrator said the staff that was responsible for screening residents and staff went in to labor unexpectedly and had a baby 4 days ago.
