Upon request of Staff B's file from the Administrator, he stated she is housekeeping and doesn't have a file. The findings from the interview with Staff B were discussed with the Administrator, in which he was informed that due to the duties of Staff B, she is acting in the role of a Direct Care staff member/Med-tech.
