Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from _____ and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (h) Reasonable opportunity for regular exercise several times a week and to be outdoors at regular and frequent intervals except when prevented by inclement weather. (i) Exercise civil and religious liberties, including the right to independent personal decisions. The notice must state that the resident may contact the State Long-Term Care Ombudsman Program for assistance with relocation and must include the statewide toll-free telephone number of the program. In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without _____, interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. A 030	Continued From page 6 A tour of the facility was conducted at 10:10am on During the tour of the 2-story home, many surface areas were observed to be covered with dirt and grime. There appeared to be a general uncleanness about the entire floor area of the facility. Stair handrails had a dingy appearance. Most of the doors within the facility had dirt and grime on them, it was very apparent because they all appeared to have been painted white and the dirt really showed up. Walls, floors, ceilings, handrails and air conditioning vents were covered in substances that with either dirt or dust and mold-like substance, throughout the building. A review of the facility's latest report from a visit on, by the local health agency, revealed that the inspection was unsatisfactory in two areas - cleanliness and the presence of a pest infestation. The report had comments stating that rodent droppings were present. The health agency's investigation found rodent droppings in the southwest corner of a vacant room of the building that was recently remodeled. The local health agency directed the facility to remove the droppings and patch the holes in the ceiling to prevent access points for rodents to enter into the building and apply effective pest management measures to prevent harborage, propagation or infestation of vermin. Also, the facility was directed to patch holes on the exterior of the building to prevent access points for vermin near the door, that was painted red, near the fire escape to the east and the front door to the east on the soffit and to remove the tree debris from the backyard and to continue to monitor for rodent activity. They further directed the facility to thoroughly clean the furniture, corners of rooms and bathrooms and remove any food debris to prevent attracting pests, and they recommended replacing residents' bed mattresses, upstairs, and providing mattress covers for new mattresses to keep them clean. A reinspection by the local health agency was scheduled for A review of the two latest pest control company service call receipts, for the facility, were dated and Both service receipts said the same thing, "monthly commercial services, treated commons areas, and entry ports into building including offices rest rooms break room hallways and storage areas. Treated exterior perimeter including windows and doors." It was noted that neither pest control service receipt mentioned treating any specific area for rats or any other infestation in any specific areas of the building. In an interview with Staff A, who is a manger of the facility, she acknowledged that the local health agency had been out to the facility recently, and they were planning to come for a revisit. She also mentioned the areas of the building that the facility was planning to repair to prevent rodent infestation, such as the holes in the ceiling and on the exterior of the building.
