Residents may be required to clean their own sleeping areas or apartments if the facility rules or the facility contract includes such a requirement. If a resident is employed by the facility, the resident must be compensated in compliance with state and federal wage laws. Any device, including half-bed rails, which the resident chooses to use and can remove or avoid without assistance, is not considered a physical 429.28 Resident bill of rights.- (1) No resident of a facility shall be deprived of any civil or legal rights, benefits, or privileges guaranteed by law, the Constitution of the State of Florida, or the Constitution of the United States as a resident of a facility. Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (e) Freedom to participate in and benefit from community services and activities and to pursue the highest possible level of independence, autonomy, and interaction within the community. The notice must state that the resident may contact the State Long-Term Care Ombudsman Program for assistance with relocation and must include the statewide toll-free telephone number of the program. In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (I) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without _____, interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. She stated her second test on was negative and she returned to work on A record review of Staff A's Covid test confirmed she was negative on In an interview on at 8:30 am with the DOH, it was confirmed that the administrator of the facility did not report within 24 hours of their staff member being positive with Covid 19 as required. DOH revealed the administrator had reported the positive test to the county days after being informed about the positive result, and the county then reported the information to DOH. DOH also confirmed when he called the facility's administrator, the administrator was non complaint and combative and would not give the date of birth of the staff member, their last day of work or if anyone could have been exposed to the staff which is required to be in compliance. DOH also stated the administrator declined the control assessment offered by DOH. On at 10am, the administrator confirmed that he did not want to violate HIPPA laws and was trying to protect the staff's privacy. He stated he reported it late to the county and thought that was the procedure for reporting COVID 19. He stated since the DOH control assessment was not required, he declined it. Class III	A 030
