The findings included: During review of the personnel file on for Staff B (Administrator), documentation of a minimum of 2 hours of continuing education in topics pertinent to nutrition and food service in an ALF could not be found. A certified food manager, licensed dietitian, registered dietary technician or health department sanitarian is qualified to train assisted living facility staff in nutrition and food service. The Administrator (Staff B) was interviewed on at 9:45 AM and stated she was responsible for the facility's food service but had not obtained the annual continuing education in nutrition.
