(Photographic evidence was obtained) In an interview conducted with the Administrator on at 3:15 PM, she stated that she was not aware that there were resident medications stored inside kitchen cabinets which did not have any locks. She stated the medications which belonged to Residents #4 and Resident #5 were medications which the residents presently received and the facility had an additional supply of these medications that were centrally stored inside the locked kitchen cabinet. She stated there was one medication container which belonged to a previously discharged resident from the facility who had been discharged a "long time ago" and this was over a year ago. She stated that the facility did not return this medication to the discharged resident and the facility also did not notify this discharged resident of the facility's possession of the medication. In an observation conducted on at 3:20 PM, the kitchen area was accessible and was without any physical barriers to the residents, staff members in the facility, or third party vendors who visited the facility. Unlicensed persons who will be providing assistance with the self-administration of medications as described in rule 59A-36.008, F.A.C., must meet the training requirements pursuant to section 429.52(6), F.S., prior to assuming this responsibility. Courses provided in fulfillment of this requirement must meet the following criteria: (a) Training must cover state law and rule requirements with respect to the supervision, assistance, administration, and management of medications in assisted living facilities; procedures and techniques for assisting the resident with self-administration of medication including how to read a prescription label; providing the right medications to the right resident; common medications; the importance of taking medications as prescribed; recognition of side effects and adverse reactions and procedures to follow when residents appear to be experiencing side effects and adverse reactions; documentation and record keeping; and medication storage and disposal. Training shall include demonstrations of proper techniques, including techniques for control, and ensure unlicensed staff have adequately demonstrated that they have acquired the skills necessary to provide such assistance. (b) The training must be provided by a registered nurse or licensed pharmacist who shall issue a training certificate to a trainee who demonstrates, in person and both physically and verbally, the ability to: 1.
