During an interview with the Administrator on at 12:56 PM, the Administrator was asked for her substitution log. She stated she decides on the main menu and sends it to the dietician to approve. She stated she always sticks to the main entree, but she changes the vegetable and does not log a substitution. The Administrator was asked why she did not offer the soup. She stated the residents have too much to eat. The 5 residents sitting at the dining room table were asked on at 1:00 PM if they wanted the chicken noodle soup. Resident #5 answered that she would like some soup. On at 1:17 PM, Resident #5 was heard saying, "what about that soup I would have liked some". An observation of the resident during this time found she had eaten everything on her plate. During further interview with the Administrator on at 1:40 PM, she was asked to provide the weekly menus for the last 6 months.
