(b) In the presence of the resident, confirming that the medication is intended for that resident, orally advising the resident of the medication name and dosage, opening the container, removing a prescribed amount of medication from the container, and closing the container. The resident may sign a written waiver to opt out of being orally advised of the medication name and dosage. The waiver must identify all of the medications intended for the resident, including names and dosages of such medications, and must immediately be updated each time the resident's medications or dosages change. (b) In addition to the specifications of Section 429.256(3), F.S., assistance with self-administration of medication includes, orally advising the resident of the name and dosage of the medication and verbally prompting a resident to take medications as prescribed. Medication, which appears to have been contaminated, must not be returned to the container. (d) Trained staff must observe the resident take the medication. Any concerns about the resident's reaction to the medication or suspected noncompliance must be reported to the resident's health care provider and documented in the resident's record. (e) When a resident who receives assistance with medication is away from the facility and from facility staff, the following options are available to enable the resident to take medication as prescribed: 1. The health care provider may prescribe a medication schedule that coincides with the resident's presence in the facility, 2. The medication container may be given to the resident, a friend, or family member upon leaving the facility, with this fact noted in the resident's medication record, 3. The medication may be transferred to a pill organizer pursuant to the requirements of subsection (2), and given to the resident, a friend, or family member upon leaving the facility, with this fact noted in the resident's medication record, or 4. Medications may be separately prescribed and dispensed in an easier to use form, such as unit dose packaging. (f) Assistance with self-administration of medication does not include the activities detailed in Section 429.256(4), F.S. (g) As used in Section 429.256(4)(h), F.S., the terms "judgment" and "discretion" mean interpreting vital signs and evaluating or assessing a resident's condition. This Statute or Rule is not met as evidenced by: Based on observation, record review and interview the facility failed to ensure proper assistance with self-administration of medications (meds) according to the required steps in 429.256 Florida Statutes for 3 (Residents #2, #3, and #4) of 3 residents sampled that required assistance with self-administration of medications. Findings Included: An observation on at 7:00 a.m. of assistance with self-administration of medications with Staff A, unlicensed personnel, dispensed medications at cart and walked to the resident's room and did not read medication out loud to Resident # 2. An observation on at 7:10 a.m. of assistance with self-administration of medications, with Staff A, unlicensed personnel, dispensed medications into a cup at the cart. She knocked on the door and entered Resident #3's room, and handed pill cup to resident without telling her what she was receiving. An observation on at 7:15 a.m. of assistance with self-administration of medications in with Staff A, unlicensed personnel, dispense medications at cart, walked to the resident's room, and did not read medication out loud to Resident # 4.	{A 052}

(b) In the presence of the resident, reading the label, opening the container, removing a prescribed amount of medication from the container, and closing the container. In an interview with the Director of Nursing conducted on _____ at 11:51 a.m., she stated the expectations of an unlicensed personnel, when assisting with medications was to identify the resident, compare the medication to the Medical Observation Record (MOR), tell the resident their medication, dispense the medication in front of the resident, watch the resident take the medication and then document as given.
