Upon completion, the employee and the administrator of the facility must sign a statement that the employee completed the required preservice orientation. The facility must keep the signed statement in the employee's personnel record. (7) Facility staff shall participate in inservice training relevant to their job duties as specified by agency rule. Topics covered during the preservice orientation are not required to be repeated during inservice training. A single certificate of completion that covers all required inservice training topics may be issued to a participating staff member if the training is provided in a single training course. 59A-36.011 (2) STAFF PRESERVICE ORIENTATION. A 081	Continued From page 3 This Statute or Rule is not met as evidenced by: Based on employee record review and staff interview, the facility failed to ensure one employee out of three sampled employees (Employee C) received one hour of Incident and Report Training and one hour of Nutrition and Safe Food Handling Training within the first 30 days of employment. The findings include: During the licensure renewal survey on employee records were reviewed. There was no evidence in Employee C's record indicating she had received the required trainings in Incident and Report Training or Nutrition and Safe Food Handling within the first 30 days of employment. During an interview with the Human Resources Director at 4:00 pm on _____, she confirmed that Employee C's hire date was _____. She stated that she reviewed the electric training program the facility uses and could not find any other trainings for Employee C except what was in her employee file (Photographic evidence obtained). At 4:15 pm on _____, the Administrator and Health and Wellness Director confirmed that Employee C was hired on _____ but did not start working shifts until later.
