In an observation conducted in on at 10:04am, live bed bugs were observed on resident's bedding. In an interview with Resident #3 conducted on at 10:04 am, she stated there were lots of bedbugs and that she even had mice on her bed. In an interview with Staff B conducted on at 10:22am, they stated there were bedbugs in the walls and that the facility needed to be tented. They stated that they had not seen a pest control company in the building and the bed bug infestation had been going on since 2020. In an interview with the Dietary and Housekeeping Manager conducted on at 11:04am, she stated she treated some rooms in for bedbugs and she tracked all of her the other rooms that needed to be treated.
