In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (1) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. (2) The administrator of a facility shall ensure that a written notice of the rights, and prohibitions set forth in this part is posted in a prominent place in each facility and read or explained to residents who cannot read. A 030	Continued From page 6 The findings included: Resident observation during the lunch meal on at 12:30 PM showed Employee A, a Home Health Aide (HHA) feeding two residents (Residents #3 and Resident #5) while standing next to them. While Employee A temporarily placed Resident #5's spoon down to feed Resident #3, Resident #5 was observed taking the spoon and feeding herself. This action of Resident #5 evidenced that she could feed herself. In the interim, Resident #4 who sat next to Resident #5 was observed playing with her plate, pushing it away and expressing dislike for her meal. During this lunch observation, the Administrator was observed standing by and did not intervene to assist HHA Employee A who tried to feed, monitor, and control the three residents seated at the table. HHA Employee A was also observed encouraging Resident #4 seated next to Resident #5 to eat, but Resident #4 refused and instead tried to spill her meal on the floor. Eventually, Resident #4 held her plate and dropped some of her meal on the floor and on her pants. Resident #4's Health Assessment (AHCA form 1820) dated showed that she was diagnosed with and required total care for all activities of daily living (ADLs). Review of Resident #3's clinical records showed that she was admitted to the facility on Her Health Assessment dated revealed that she was diagnosed with and She required assistance with eating, walking, and transferring. A 030	Continued From page 7 Review of Resident #6's Health Assessment dated showed that she was diagnosed with and Resident #6 required assistance to eat. In addition, while Resident #3, Resident #4, and Resident #5 were at the table eating, Resident #6 was observed seated right behind them in a wheelchair and no one was feeding her. Resident #6 was noted to be asleep. Although the Administrator was present during this observation, it was noted that no feeding assistance was offered to Resident #6 while Residents #3 and Resident #4 were being fed. During an interview conducted with HHA Employee A, on at 12:35 PM, HHA Employee A reported that she usually is the only one feeding the residents every day. She informed that Resident #5 is able to feed herself, however she had to start feeding her in order to initiate the process and stimulate Resident #5 to continue the process. She said that this action was important due to Resident #5's diagnosis of Yet, she was observed to practically feed Resident #5 from start to finish. In an interview conducted with the Administrator on at 12:45 PM to inquire about her lack of involvement in the dining process, she indicated that HHA Employee A could handle the residents. Then, in reference to Resident #6 not being fed, the Administrator said that she thought she was already fed. Despite that exchange with the Administrator, Resident #6 was left unattended and was not fed until after Residents #3 and Resident #4 were done eating.	A 030

CZ830	408.821 FS Emergency Management Planning 408.821 Emergency management planning; emergency operations; inactive license.- (1) A licensee required by authorizing statutes and agency rule to have a comprehensive emergency management plan must designate a safety liaison to serve as the primary contact for emergency operations. Such licensee shall submit its comprehensive emergency management plan to the local emergency management agency, county health department, or Department of Health as follows: (a) Submit the plan within 30 days after initial licensure and change of ownership, and notify the agency within 30 days after submission of the plan. (b) Submit the plan annually and within 30 days after any significant modification, as defined by agency rule, to a previously approved plan. (c) Submit necessary plan revisions within 30 days after notification that plan revisions are required. (d) Notify the agency within 30 days after approval of its plan by the local emergency management agency, county health department, or Department of Health. (2) An entity subject to this part may temporarily exceed its licensed capacity to act as a receiving provider in accordance with an approved comprehensive emergency management plan for up to 15 days. While in an overcapacity status, each provider must furnish or arrange for appropriate care and services to all clients. In addition, the agency may approve requests for overcapacity in excess of 15 days, which approvals may be based upon satisfactory justification and need as provided by the receiving and sending providers. Suffered damage to its operation during the state of emergency. 2. Is currently licensed. 3. Does not have a provisional license. 4. Will be temporarily unable to provide services but is reasonably expected to resume services within 12 months. (b) An inactive license may be issued for a period not to exceed 12 months but may be renewed by the agency for up to 12 additional months upon demonstration to the agency of progress toward reopening. A request by a licensee for an inactive license or to extend the previously approved inactive period must be submitted in writing to the agency, accompanied by written justification for the inactive license, which states the beginning and ending dates of inactivity and includes a plan for the transfer of any clients to other providers and appropriate licensure fees. Upon agency approval, the licensee shall notify clients of any necessary discharge or transfer as required by authorizing statutes or applicable rules. The beginning of the inactive licensure period shall be the date the provider ceases operations. The end of the inactive period shall become the license expiration date, and all licensure fees must be current, must be paid in full, and may be prorated. Reactivation of an inactive license requires the prior approval by the agency of a renewal application, including payment of licensure fees and agency inspections indicating compliance with all requirements of this part and applicable rules and statutes.
