This designation may be made at the time of initial licensure or relicensure or upon request in writing by a licensee under this part and part II of chapter 408. Notification of approval or denial of such request shall be made in accordance with this part, part II of chapter 408, and applicable rules. This training must be provided by or approved by the Department of Children and Families. 59A-36.011 (9) LIMITED MENTAL HEALTH TRAINING. (a) Pursuant to section 429.075, F.S., the administrator, managers and staff, who have direct contact with mental health residents in a licensed limited mental health facility, must receive the following training: 1. A minimum of 6 hours of specialized training in working with individuals with mental health diagnoses. a. For administrators and managers, the continuing education requirement under this subsection will satisfy 3 of the 12 hours of continuing education required biennially pursuant to section 429.52(5), F.S., and subsection (1) of this rule. 4. Administrators, managers and direct contact staff affected by the continuing education requirement under this subsection shall have up to 6 months after the effective date of this rule to meet the training requirement. This Statute or Rule is not met as evidenced by: Based on observation, record review and interview the facility failed to assure that one out of four sampled staff that worked with individuals with limited mental health diagnosis received the Limited Mental Health (LMH) training (Staff B). Findings as follow: On at 9.15 AM Staff B (caregiver) was observed working in facility with a census of 5 residents. Review of Facility Finder database showed the facility hold an standard license with limited mental health component. Review of the Facility's Background Screening database staff roster showed Staff B was hired on Review of Staff B's record showed there was not documentation on the record about the Limited mental health training. Review of the admission/discharge log showed three residents were identified as being served under the facility's LMH license. On at 11.30 AM the Administrator stated Staff B had not received the Limited mental health training but she was already registered to received it on	AL243
