Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (e) Freedom to participate in and benefit from community services and activities and to pursue the highest possible level of independence, autonomy, and interaction within the community. The notice must state that the resident may contact the State Long-Term Care Ombudsman Program for assistance with relocation and must include the statewide toll-free telephone number of the program. In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. (I) Present grievances and recommend changes in policies, procedures, and services to the staff of the facility, governing officials, or any other person without _____, interference, coercion, discrimination, or reprisal. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. This right includes access to ombudsman volunteers and advocates and the right to be a member of, to be active in, and to associate with advocacy or special interest groups. (2) The administrator of a facility shall ensure that a written notice of the rights, _____, and prohibitions set forth in this part is posted in a prominent place in each facility and read or explained to residents who cannot read. Review of Resident #13's facility record documented a "Notice to Vacate for Non-Emergency Relocation," dated _____ with a termination effective date of _____. The 45-day written notice did not provide a reason for the notice to vacate. On _____, at 1:20 PM, an interview was conducted with the Administrator of the facility. The Administrator stated there were a myriad of reasons for the termination. She stated she had spoken with Resident #13's daughter, Resident #13's Power of Attorney (POA), on multiple occasions, and had given the POA and Resident #13 multiple chances but, nothing changed. She further stated, "I was left with no alternative than to issue the 45-day notice. [Resident #13's name] needed more oversight than this facility could provide, and her daughter was never satisfied with what we tried to do so this was a last resort, but not one entered into lightly." On _____, at approximately 4:15 PM, a follow-up interview was conducted with the Administrator. She was asked to read the 45-day letter of termination and after doing so, confirmed that it did not specify a reason as to why the notice was issued. She further stated, "This is a form letter which we have been using but, it is in the process of being changed with the higher-ups right now."	A 030
