In order for a facility to terminate the residency of an individual without notice as provided herein, the facility shall show good cause in a court of competent jurisdiction. Each facility shall establish a grievance procedure to facilitate the residents' exercise of this right. Also, the facility failed to log the resident's family member's verbal grievance and any attempts to resolve the grievance. Findings included: Review of the facility's policy on grievances shows on admission the resident or the resident's family member is given written information on the facilities grievance procedure and that this is documented by the family member initialing they have received the information at that time. Upon entrance to the facility, the log for grievances over the last 6 months was requested. On at 10:30 a.m., the Executive Director (ED) reported there had been no grievances over the last 6 months. On at 11:00 a.m., Resident #6's daughter stated someone at the facility had stolen the resident's TV. She said she reported this to the ED and had not received any response as to what had happened to the TV. On at approximately 1:30 p.m., the ED verified she had spoken with Resident #6's daughter regarding the TV. The ED said she had attempted to find the TV and was told by a staff member the TV was dropped and damaged and thrown away. The ED said she never actually had seen the damaged TV. And did not remember when the TV was discarded. The ED verified this incident had not been logged as a grievance. The ED said she had not documented the issue in a progress note.
