Findings as follow: On at 8:50 AM Resident #3 was observed in bed with full bed rails in upright position, she was laying on her left side, she had a pillow between and she was using bootie bunnies in both . On at 11:45 AM Staff B and C stated Resident #3 had her and rigid, she was bathed in bed and staff fed the resident. On at 12:10 AM the Administrator stated Resident #3 used to transfer with assistance but she had declined in the last month. He said pillow and bootie bunnies were used to avoid resident develop an , he said resident skin was intact. Review of Resident #3's Health Assessment (Form 1823) dated showed she was diagnosed with type II, High , legally and and resident needed supervision-eating, and assistance-with ambulation, bathing, self-care, toileting, transferring and self-administration of medications.
