Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (e) Freedom to participate in and benefit from community services and activities and to pursue the highest possible level of independence, autonomy, and interaction within the community. (f) Manage his or her financial affairs unless the resident or, if applicable, the resident's representative, designee, surrogate, guardian, or attorney in fact authorizes the administrator of the facility to provide safekeeping for funds as provided in s. 429.27. On at 11:36 AM, Staff B stated, "No, no one here eats puree, they all eat regular food." At 11:51 AM, Staff C stated, "Everyone eats regular food, no one eats puree or any special diet. At 12:05 PM, when Staff C was asked about his diet, Staff C stated, "When he came the first time, he was eating soft foods. When the family comes, they ask what he eats. He asks his family to bring him other foods, and the family is the one who asked us to give him regular food." According to Very Well Health, "A pureed diet is an eating plan where all the foods have a soft, pudding-like consistency. It is texture-modified diet that is often recommended for people who can't eat solid foods. A pureed diet includes soft, smooth foods. If you are having trouble chewing, swallowing, or digesting, it may not be safe for you to eat solid food as you typically would.
