Interviewed on _____ at 1:15 PM the Owner stated Resident #3 left the facility and she did not know where the resident was and the resident did not call her. The Owner stated the elopement happen about three months ago. The Owner stated she called the resident sister. Interviewed on _____ at 4:03 PM the family of Resident #3 regarding Resident #3 leaving the facility, the family stated that there was one time they [facility staff] did not know where she (Resident #3) went. The sister stated that she [Resident #3] went to the store and did not return to the facility. The sister stated, "The owner called me to looking for her. My sister called me. I could not remember how long she was gone." A review of the facility's elopement policy showed: "Any elopement attempt or actual elopement will be documented in resident's file. Elopement means an occurrence in which a resident leaves a facility without following facility policy and procedures. Elopement is defined when a resident leaves the facility's property beyond the perimeter of the parking lot or further, he/she is missing for more than 24 hours, he/she leaves without the facility's knowledge because he/she has not verbally informed the facility of their plans for returning to the facility. Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (e) Freedom to participate in and benefit from community services and activities and to pursue the highest possible level of independence, autonomy, and interaction within the community.
