The registration must include the person's full first name, middle initial, and last name; social security number; date of birth; mailing address; and race. Individuals, persons, applicants, and controlling interests that cannot legally obtain a social security number must provide an individual taxpayer identification number. This Statute or Rule is not met as evidenced by: Based on record review, and interview, the provider failed to ensure 1 (Staff C) of 4 staff records reviewed, had the Level 2 Background screening employment status updated within 10 days on the Agency's Background Screening Clearinghouse pursuant to Chapter 435.
