A 162	Continued From page 3 Based on observation, record review and interview the facility failed to have accurate health assessments for 2 out of 5 sample residents (Residents #5 and #4). The facility also failed to have documentation of the existence of a Power of attorney for 1 out of 5 sample residents (Resident #4). Findings as follow: On at 8:00 AM Resident #5 was observed in bed with full bedrails in upright position and Resident #4 was observed sitting in the Florida room. Review of Resident # 5's Health Assessment dated showed resident was not bedridden. Review of Resident #4's Health Assessment (Form 1823) dated showed the section referred to the type of diet resident needed was not completed 2. Review of Resident #4 's Contract dated showed it was signed by resident's family member. Further review showed the facility did not have a copy of the Power of Attorney on behalf of the resident. On at 11:00 AM the Administrator stated Resident #5 was bedridden. He then said he would request new Health Assessments to the physicians of Residents #4 and #5 adding he asked several times Resident #4' family about the Power of Attorney but they have not provide it.
