Findings included: On 8/27/2024 at 10:10 AM, observation showed Resident #1 lying in bed with full side bed rails in the upright position. Review of Resident #1's record revealed a prescription order for full side bed rails dated 8/27/2024. Further review showed no documentation of a signed consent for the use of full bed rails. A review of Resident#1's health assessment dated 8/27/2024 showed the medical history and diagnoses were not listed nor was the resident's functional or behavioral status. The physician indicated that the resident required 24-hour nursing or personal care. Additionally, the resident needed total care with all activities of daily living: ambulation, bathing, dressing, eating, self-care (grooming), toileting, and transferring, and administration of medication. Resident #1 was receiving hospice services since 8/27/2024.
