(b) In addition to the specifications of Section 429.256(3), F.S., assistance with self-administration of medication includes, orally advising the resident of the name and dosage of the medication and verbally prompting a resident to take medications as prescribed. (c) In order to facilitate assistance with self-administration, trained staff may prepare and make available such items as water, juice, cups, and spoons. Trained staff may also return unused doses to the medication container. Medication, which appears to have been contaminated, must not be returned to the container. (d) Trained staff must observe the resident take the medication. Any concerns about the resident's reaction to the medication or suspected noncompliance must be reported to the resident's health care provider and documented in the resident's record. (e) When a resident who receives assistance with medication is away from the facility and from facility staff, the following options are available to enable the resident to take medication as prescribed: 1. The health care provider may prescribe a medication schedule that coincides with the resident's presence in the facility, 2. She entered the common TV area with the 2 pill bottles, identified resident #4 by name, identified the medication by name, dose, time, and observed resident #4 being able to take her medications without any assistance updating the MORs afterwards. Review of resident #5's 1823 health assessment indicated needs assistance with self-administration of medications. On at 5:50 PM, unlicensed caregiver A performed proper hygiene according to policy (before, during, after med pass), removed resident #5's medication from the locked closet, reviewed the medication observation records (MORS) prepared the medication outside of the presence of the resident by popping the 1 tablet into the medicine cup. She entered the dining room with the empty pre-package container, the medicine cup, identified the resident by name, identified the medication by name, dose, and time. The unlicensed caregiver stated to resident #5, "hold your up, open your so you can take your medicine." The unlicensed caregiver placed the medicine cup to resident #5's and without any assistance from the resident, continued to pour the medicine into resident #5's following up by having the resident to drink from her teal-colored water bottle. On _____ at 5:57 PM unlicensed caregiver A stated I'm to wash my _____ before starting the med pass. I review the MORs, get the medication from the locked closet, take the medications and water to the residents, state the name and dose of the medicine, make sure they take it, update the MORs, and wash my _____ after each resident. The caregiver stated when asked why she didn't prepare the medications in the presence of the residents. I was nervous. I know I'm supposed to prepare in front of them. For resident #5, since she doesn't hold the medicine cup. I hold it for her. Sometimes she'll do it, but I just do it for her to make sure she takes it. Unlicensed caregiver A was made aware of the correct process is to prepare the medications in the presence of each residents and to only assist with administering. If a resident requires administration she will need to inform the administrator. The administrator was made aware of unlicensed caregiver A's improper med passes for resident #4 and #5.
