However, the review did not reveal a Resident Health Assessment Form (AHCA form 1823) document in the file. Observation of Resident #1s Sheet documented his diagnosis as Iron deficiency, . Type II, (severe). However, the file did not have an AHCA Form 1823 (1823) documenting that the Resident met the requirements for admission into the facility. In an interview with the Administrator, Director of Nursing (DON) and Executive Director on at 12:03 PM they were informed that the resident did not have an 1823 in his file and provided them an opportunity to review the file. They were unable to locate any 1823s. The Administrator stated she has been going through resident paperwork since she started on and saw a deficiency where the previous ownership took files offsite that they should not have. The Administrator further stated in the interview that they told the previous DON that they needed the 1823s in the files, as they had discovered they do not have current 1823's on file for some residents.
