The registration must include the person's full first name, middle initial, and last name; social security number; date of birth; mailing address; and race. Individuals, persons, applicants, and controlling interests that cannot legally obtain a social security number must provide an individual taxpayer identification number. This Statute or Rule is not met as evidenced by: Based on record review and interview, the facility failed to report on the initial employment status to the Clearinghouse for one out of eight staff sampled (Staff I). Findings included: A review employee application revealed Staff I was hired on . A review of Staff I's background screening was dated eligible with no employment history. Review database for employee roster revealed that Staff I was not listed as an employee.
