Findings included: 1) On at 1:20 PM Resident #2's daughter stated, "my mother had come from the activities room and had gone to the bathroom. Resident#2 saw the door on the side of the building wide open and she walked through it. The building by the offices. The side door was open and so she went out. The private duty nurse went in to check on my mom in the bathroom and told me I will wait for you in the front area." In an interview on at 1:20 PM Resident #2's daughter stated, she was being checked on by private duty nurse while she was in the bathroom. The nurse informed the resident that she would wait for her in the front area, which was part of her usual routine. Resident #2 agreed. When the resident exited the bathroom, she noticed another door open and walked through it, which led her outside where she could see the side of the building. When she realized she was outside she attempted to go inside but found that the door was locked. Because the resident was familiar with the area, she walked to the nearby grocery store to get some bananas without paying and then left the store. The facility did not have 24-hour staffing and the residents had never done this before. The private duty nurse had been caring for Resident #2 for several years. The facility had recommended Resident #2 to be moved to memory care. The daughter stated she did not require that level of care. Resident #2's daughter later had her evaluated by a nurse at another facility that could provide the appropriate services and care she needed and that Resident #2 transitioned there. In an interview on _____ at 1:27 PM Resident #2's private duty nurse stated that she had worked with Resident 2 for many years. The resident was placed and seated in the activity room in the theater, while the private duty nurse sat in the lobby where she could see her when the activities ended. As the other residents began to leave, she did not see her. Resident 2 usually went to the nearby bathroom so the private duty nurse assumed she was there. She checked the activity room and then the bathroom and did not find her. She also checked her apartment and she was not there. The private duty nurse asked the facility to review the cameras, but the front desk didn't have access. The private duty nurse stated there was no way the residents could have left without being seen. The resident's daughter and the private duty nurse later went to a nearby grocery store, where they found the Resident #2 seated in a police car with bananas in her. The daughter and the private duty nurse were asked if Resident #2 had any identifiers on her persons to identify who she was and where she belonged and they both stated "no."	A 032
