(f) Residents may not be required to perform any work in the facility without compensation, except that facility rules or the facility contract may include a requirement that residents be responsible for cleaning their own sleeping areas or apartments. If a resident is employed by the facility, the resident shall be compensated, at a minimum, at an hourly wage consistent with the federal minimum wage law. The facility shall not prohibit unidentified telephone calls to residents. Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from _____ and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individually, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. No religious beliefs or practices, nor any attendance at religious services, shall be imposed upon any resident. (j) Access to adequate and appropriate health care consistent with established and recognized standards within the community. This Statute or Rule is not met as evidenced by: Based on observation and interviews the Hidden Pines Assisted Living facility failed to provide a safe and decent living environment for all residents. Findings: On at approximately 10:30 AM interview with the Manager about her having any knowledge of residents possessing swords or knives, which she said residents are not allowed to have those items. On at approximately 10:45 AM during a tour of the Hidden Pines Assisted Living Facility it was observed that both the front and back porch areas where residents smoke contained numerous spider webs. It was observed inside the front porch area a black spider with a red hour glass shape on its belly living in the corner by the door. A resident who saw the spider said it was a Black Widow. It was also observed that the back porch had several spittle stains on the floor and walls. On at approximately 11:30 AM during an interview with resident #2 an anonymous resident #6 made complaints about all the spider webs on the porches and spittle stains. She also said she was worried about getting bit by a spider, when she uses the porch areas to smoke.	A 030
