Findings include: During facility tour on at approximately 9:00 a.m., the bed for resident #2 was observed to have 1/2 bed-rails installed improperly on the bed creating a potential safety hazard. The 1/2 bed-rails were placed in the center of the bed on each side rather than being installed at the head of the bed. During staff interview at 1 p.m., staff confirmed that the resident needed the bed-rails for safety to prevent falling out of bed. Staff said the bed-rails were put in up position at night. 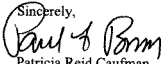
