If a resident is employed by the facility, the resident shall be compensated, at a minimum, at an hourly wage consistent with the federal minimum wage law. (g) The facility shall provide residents with convenient access to a telephone to facilitate the resident's right to unrestricted and private communication, pursuant to Section 429.28(1)(d), F.S. The facility shall not prohibit unidentified telephone calls to residents. For facilities with a licensed capacity of 17 or more residents in which residents do not have private telephones, there shall be, at a minimum, an accessible telephone on each floor of each building where residents reside. Every resident of a facility shall have the right to: (a) Live in a safe and decent living environment, free from _____ and neglect. (b) Be treated with consideration and respect and with due recognition of personal dignity, individuality, and the need for privacy. (c) Retain and use his or her own clothes and other personal property in his or her immediate living quarters, so as to maintain individuality and personal dignity, except when the facility can demonstrate that such would be unsafe, impractical, or an infringement upon the rights of other residents. (d) Unrestricted private communication, including receiving and sending unopened correspondence, access to a telephone, and visiting with any person of his or her choice, at any time between the hours of 9 a.m. and 9 p.m. at a minimum. Upon request, the facility shall make provisions to extend visiting hours for caregivers and out-of-town guests, and in other similar situations. (g) Share a _____ his or her spouse if both are residents of the facility. (h) Reasonable opportunity for regular exercise several times a week and to be outdoors at regular and frequent intervals except when prevented by inclement weather. (i) Exercise civil and religious liberties, including the right to independent personal decisions. No religious beliefs or practices, nor any attendance at religious services, shall be imposed upon any resident. (j) Access to adequate and appropriate health care consistent with established and recognized standards within the community. (k) At least 45 days' notice of relocation or termination of residency from the facility unless, for medical reasons, the resident is certified by a physician to require an emergency relocation to a facility providing a more skilled level of care or the resident engages in a pattern of conduct that is harmful or offensive to other residents. This Statute or Rule is not met as evidenced by: Based on observation, the facility failed to ensure the walls were intact and in good appearance. The findings include: Upon arrival in the home, a tour was performed starting at 9:30 a.m. on _____. In the back hallway extending from one side of the _____, the other, there was an area of scrapped, black appearing along the entire wall at approximately 1 foot from the floor. In the dining _____, the entire wall leading to the outside were 2 areas of blackened scrapped paint. One was low on the wall approximately 1-1.5 feet from the ground and the other was approximately 4 feet from the ground. Additionally, there were scrapes and bare wallboard along the entire back wall of the _____. This area was about 4.5 feet from the floor. In the back hallway adjacent to the kitchen, there was also scrapes and the wallboard was exposed in places in the area low on the wall. During an interview on _____ at 4:00 p.m. the attendant in charge indicated they were aware of these areas. She stated they had been painted not so long ago and they were already bad.
