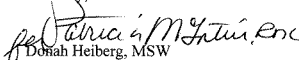
This letter reports the findings of a complaint survey completed on September 14, 2012 by a representative of this office.

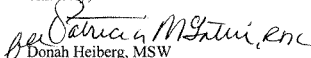
Dear Ms. Walker:
