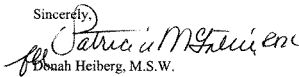
This letter reports the findings of a biennial state licensure survey that was conducted on January 2, 2012 by representatives of this office.

Attached is the provider's copy of the State (3020) Form, which indicates the deficiencies that were identified on the day of the visit. Section 408.811(4), Florida Statutes, requires that you correct these deficiencies within thirty days of the date of this letter unless the Agency has approved another timeframe. Staff from this office will conduct a review after January 2, 2012 to verify that the necessary corrections are in place to correct the deficiencies identified on your survey.
