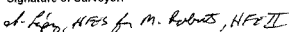

Interview with resident #1 on at 11:55 AM revealed she stated staff member #5 accompanied her to an appointment with the "live-in" staff #6. Resident #1 held up three fingers as she stated "she (staff #5) was in the car with us; there were 3." Interview with resident #2 on at 12:10 PM revealed she stated that staff member #5 interacts with residents and is in the common area "all the time."
