(f) Residents may not be required to perform any work in the facility without compensation, except that facility rules or the facility contract may include a requirement that residents be responsible for cleaning their own sleeping areas or apartments. If a resident is employed by the facility, the resident shall be compensated, at a minimum, at an hourly wage consistent with the federal minimum wage law. No exceptions." It was clear from the tour conducted that this policy was not being followed. The yard was littered with bottles, cans and trash. The screened outside area was littered with paper. The Administrator agreed that the policy was not being followed and stated that the Maintenance Director was responsible for this area. In an interview with the Maintenance Director held in the afternoon of _____ he agreed that he hadn't completed this responsibility. In an interview with Resident #3 on the _____ at 10:12 AM, the Resident reported two second shift staff members were guilty of _____ while administering medications.
