

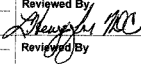

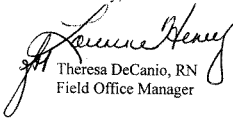
This letter reports the findings of a state licensure survey revisit conducted on June 10, 2013 by representative(s) of this office.
