An unannounced survey was conducted at At Home Assisted Living Facility, Inc., in Eustis, Florida on 2013. The facility was not in compliance with 429.01-429.54, Part I & 408, Part II, Florida Statutes, and 58A-5 & 59A-35, Florida Administrative Code.

Based on record review and interview, the facility failed to verify freedom from communicable for the two of three sampled employees.

Findings:

A record review conducted on, 2013, revealed that the facility could not verify that employees B and C are free from communicable An interview was conducted with the administrator on, 2013. She acknowledged that the files did not contain the required documentation.
