0000-Initial Comments

On [redacted] unannounced change of ownership was conducted at KYR Tender Care Assisted Living Facility in Eustis Florida. Discernible deficiencies were identified as a result of this survey. The facility was not in compliance at this time.

0078-Staffing Standards - Staff 58A-5.019(2) FAC

Based on record reviews and interviews the facility failed to have annual documentation from a health care provider for showing for 2 of 2 staff members reviewed were free from [redacted] (Administrator and Staff B).

The findings include:

1. On [redacted] an employee record review was conducted. A review of the Administrator's record revealed no documentation of annual freedom from [redacted].
2. On [redacted] Staff B's employee record was reviewed. A review of Staff B's record revealed Staff B's last documentation of freedom from [redacted] was completed on [redacted].
3. On [redacted] at approximately 4:20 PM an interview was conducted with the Administrator about there not being an annual freedom from [redacted] statement in her record. The administrator stated she went to the doctors on [redacted] and got a freedom from communicable [redacted] statement and she thought she had a [redacted] test done as well. On [redacted] at approximately 4:25 PM the Administrator called the doctor's office where she received her free from communicable [redacted] statement on [redacted]. The doctor's office told her they do not have a record of her getting a [redacted] test there. They only gave her a clearance for being free from a communicable [redacted]. On [redacted] at approximately 5:00 PM the Administrator was asked why Staff B did not have a current freedom from [redacted] statement. The Administrator stated that it had just recently expired and it was overlooked.
