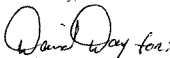
This letter reports the findings of a state licensure survey that was conducted on , 2014 by representative(s) of this office.

0000-Initial Comments

On 01-29-30, 2014 an unannounced Biennial and Extended Congregate Care Licensure survey was conducted at Brentwood @ Fore Ranch located in Ocala, Florida. A deficiency was identified as a result of this survey. The facility was not in compliance at this time.

A Complaint survey, CCR#2014000897, was conducted in conjunction with the Biennial/ECC survey. There were no deficiencies identified as a result of the complaint survey.

0086-Training - ADRD 58A-5.0191(9) FAC

Based on employee training record review and interview the facility failed to ensure that 1 (Employee A) of 3 employees received the required 4 hours of training within 3 months of employment.

The findings include:

Review of the employee training documentation revealed that Employee A (date of hire 01-29-14) has not received the required 4 hours of Level 1 and Level II training. Observations of the employee revealed that she works in the Memory Care Unit.

During the interview with the administrator on 01-30-14 at 11:00 am he stated that he was recently hired and was not aware of the staff who have not received all of their training.
