Based on observation, record review and interview the Assisted Living Facility failed to obtain the written doctor order for the use of full-bed rail and resident's consent to use full-bed rail for 1 out of 1 sampled residents (#1).

Findings include:

1. Observation on at approximately 8 a.m. revealed that on : # | resident #1 was lying on bed with full bed rail up.
2. Record review for resident #1's file revealed that there was no written doctor order for the use of full bed rail either a resident's consent to use full bed rail. There was a consent for the use of half-bed rail dated and signed and doctor order for half-bed rails dated .
