An unannounced limited nursing services monitoring survey was conducted on . Edelmira Alf li Inc
had deficiencies at the time of the survey.

Based on observation, record review and interview the Assisted Living Facility failed to the written order of the resident's physician to the use of half-bed rail for one out of one sampled residents (#1).

Findings include:

1. Observation during tour of the facility on at 10:15 a.m. revealed that resident #1's bed had attached a half-bed rail to his/her bed.
2. Record review of resident #1's file revealed that there was no written physician order for the use of half-bed rail.
3. In an interview with caregiver_A on at 10:25 a.m. revealed that resident #1 used half-bed rail up while on bed.
