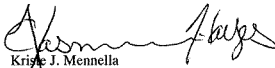
This letter reports the findings of a state licensure survey that was conducted on , 2014 by representative(s) of this office.

An unannounced biennial licensure survey was conducted at Prestige Manor in Bellevue, Florida on 2013. Licensure deficiencies were identified as a result of the survey. The facility was not in compliance with 58A-5, FAC and Chapter 429, Part I, FS.

Based on personnel record review, and interview the facility failed to ensure that 1 (Staff C) of 3 sampled employees had a Level II background screen after having a gap in employment greater than 90 days.

Finding:
