0000-Initial Comments

On an unannounced **biennial licensure** survey was conducted at Always There Assisted Living Facility in Inverness, Florida. Discernible deficiencies were identified as a result of this survey. The facility was not in compliance at this time.

0093-Food Service - Dietary Standards 58A-5.020(2) FAC

Based on observations and interviews the facility failed to show portion sizes on menus or a separate sheet for 6 of 6 residents in the facility (Residents #1-6).

Findings:

On at approximately 12:00 PM a food service dining review was being conducted of the facility menu. It was observed that there were no portion sizes on the menu.

On at approximately 5:15 PM during an exit interview the Administrator was asked if there was a separate sheet where portion sizes are listed for the facility menus. She stated no she did not have a separate sheet which contained portion sizes. She stated the dietician usually lists them on the menu and why it was not done this past time she did not know. She said it was an oversight by her.
