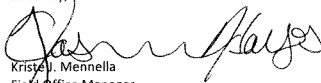
This letter reports the findings of a Limited Nursing Services licensure monitoring survey that was conducted on 2014 by representative(s) of this office.

On . 2014 an unannounced Limited Nursing Services Monitoring survey was conducted at Mayfield Retirement Assisted Living Facility located in Leesburg, Florida. The facility was not in compliance. A deficiency was cited.

Z815-Background Screening; Prohibited Offenses 408.809, 435.02(2), 435.06

Based on personnel record review and interview the facility failed to conduct a Level II Background screening on 1 of 1 employee prior to employment.

Finding:

Review of the registered nurse's record who was hired to conduct the assessments for the Limited Nurses Services program revealed that she did not have the required Level II background screening. During the interview with the administrator on . at 9:30 am she stated that she was not aware of the regulation and that the nurse has been employed at the facility since 2010.
